CANDIDACY REQUIREMENTS FOR DISTRICT GOVERNOR - a candidate for the office of District Governor shall:

- (a) Be an active member in good standing of a chartered Lions club in good standing in his/her District.
- (b) Secure the endorsement of his/her club or a majority of the clubs in his/her District.
- (c) **Currently be serving as the 1st Vice District Governor within the District from which he/she is to be elected.**

NOMINATIONS 1ST VICE DISTRICT GOVERNOR 2019/20

CANDIDACY REQUIREMENTS FOR 1ST VICE DISTRICT GOVERNOR - a candidate for the office of 1st Vice District Governor shall:

- (a) Be an active member in good standing of a chartered Lions club in good standing in his/her District.
- (b) Secure the endorsement of his/her club or a majority of the clubs in his/her District.
- (c) **Currently be serving as the 2nd Vice District Governor within the District from which he/she is to be elected.**

As we have a serving 1st VDG Daniel Stevens (Bassendean Lions Club), and 2nd VDG Michael (Mick) Wainwright (Noranda Lions Club) these positions are not open to other Lion members and they will go forward with their club's endorsement as



candidates for the position of District Governor and 1st VDG for the 2019/20 Lionistic Year. We have received in writing endorsements for both candidates from their respective clubs.

A secret written ballot will be undertaken by the nominations committee at this year's convention with the candidates required to secure a majority of the votes cast by the delegates present and voting in order to be declared elected; for purpose of such election, a majority is defined as a number more than one-half of the total valid votes cast. The same applies to 2nd VDG below.

NOMINATIONS 2ND VICE DISTRICT GOVERNOR 2019/20

Nominations for the position of 2nd VDG for the 2018/19 Fiscal Year is now open to all members who qualify.

CANDIDACY REQUIREMENTS FOR 2ND VICE DISTRICT GOVERNOR -

1. Be an active member in good standing of a chartered Lions Club in good standing in his/her District.
2. Secure the endorsement of his/her club or a majority of the clubs in his/her District.
3. Have served or will have served at the time he/she takes office as Second Vice District Governor –
 - (a) As President of a Lions club for a full term or major portion thereof, and a member of the board of directors of a Lions club for no less than two (2) additional years; and
 - (b) As zone chairperson or region chairperson or cabinet secretary and/or treasurer for a full term or major portion thereof.
 - (c) With none of the above being accomplished concurrently.

Each club should lodge their statements after their AGM. The information statement is vital in demonstrating to Consumer Protection that your association is active and meeting its legal responsibilities. 1. Click on Consumer Protection link above.
2. Login to the AssociationsOnline.
3. Click on Lodge Application
4. Click on the down arrow to the right of your club name.
5. Choose Information Statement and click the Go button and follow instructions.
